Annual Report: 2013

1.0 **SUMMARY OF MAJOR ACTIVITIES**

Several activities took place during 2013:

A key event at the beginning of the year was the roll-out the library orientation programme for both

first-year students and new staff members. The first-year induction at the Bloemfontein campus

took place from 23 – 25 January 2013. The induction was primarily intended to introduce students

to the wealth of information sources available at the library, focusing on how to access required

information. After an oral presentation by library staff members to welcome students and provide

general guidance on the use of the library, students watched a DVD about the library facilities and

services available to them. Each student received an orientation package consisting of a CD

containing an orientation manual; a concise pamphlet about CUT's libraries; and some

CUT-branded marketing materials. The DVD presentation was followed by a conducted tour of the

library. At the end of each tour, students were asked to complete a questionnaire to provide

feedback on their experience of the orientation programme.

The 2013 induction programme was lead by Mr A Mkam. Thanks to the support and cooperation of

many library staff, who volunteered to participate in the planning and implementation of the

programme, the orientation was well-organised and executed. However, the attendance could

have been better. Only 237 students managed to complete the induction programme. At the

beginning of 2012, the library recorded 361 attendees for the library orientation. The fact that the

library induction took place simultaneously with faculty orientation partly contributed to the poor

attendance. On the other hand, some students were involved in the registration process when the

library induction was in session. However, we could seek consolation in the fact that the library

orientation was an on-going activity throughout the academic year. Students or programme heads

were at liberty to approach the library and arrange individual and group sessions. 21 academic staff

members attended the library orientation.

The induction of new students at the Welkom campus was conducted on 15 February 2013. Only

39 students attended. Our information section arranged a special induction for new students from

18 – 22 February 2013 in the library hall as part of their personal information management (PIM)

training. The event was well-attended, and a total of 345 individuals were inducted and orientated.

• The national Library Week celebrations took place from 15 − 23 March 2013. The Library Week takes place annually in March, with the purpose of acknowledging the importance and contributions of libraries to nurturing the information society; enriching cultures; and fostering socio-economic development. Celebrations with the theme "Develop yourself @ your library" were held across the country.

On 15 March 2014, CUT hosted the Free State Province launch of the Library and Information Association (LIASA)'s Library Week. The event attracted people from a cross-section of library communities, including higher education, public libraries, FET colleges and learners from three high schools. A welcoming speech was made by the Dean of Research and Innovation, Professor LOK Lategan. The keynote address was presented by the CUT Deputy Librarian: Systems Development, Ms DR Ackerman. It is worth mentioning that CUT received recognition for a well-organised event.

A series of other activities were organised for the Library Week celebrations at both the Bloemfontein and Welkom campuses. The main event was the official launch of the Library Week on 18 March 2013. Invitations to the launch were sent to the senior management of CUT, deans, head of academic departments, research professors, members of the library group and SRC representatives. Library staff were also invited. The launch was meticulously planned, and a keynote address was given by the Vice-Chancellor of CUT. Service providers in events management were contracted to ensure grandeur and splendour in the arrangement of the Art Gallery, which served as the venue for a colourful and auspicious occasion. Beautiful art works provided the backdrop to the venue. At the end of the formal presentations and discussions, participants were treated to snacks and cocktails. An attractive display of more recent research publications was also mounted. Credit should go to the library staff for organising such a wonderful event.

On the same day (18 March 2013), the library offered a database demonstration to staff. It had become customary for the library, at any given opportunity, to familiarise library clients to online full-text databases that the library subscribe to. This was particularly important, considering the large pool of information resources accessible online. Effective use of such resources could only be made if staff were familiar with the search techniques. A similar training session was conducted for students at the amphitheatre on 19 March 2013, with emphasis on the use of technology, including mobile phones; laptops; iPads; etc., to access library resources. Access to mobile technology was

donated by Cell C. To support and help cultivate a culture of reading, the library donated newspapers and magazines to "Motswedi wa Thuto", an independent, non-profit community organisation with the objective of empowering learners/the youth in information skills. Events that took place at Welkom campus to commemorate Library Week included the official opening of the audio-visual facility in the library; a database training session; and a debate on human rights.

• The library celebrated World Book and Copyright Day on 23 April 2013. World Book and Copyright Day was established by the United Nations Educational, Scientific and Cultural Organisation (UNESCO) at its General Conference in 1995. This day offers an opportunity to reflect on better ways to disseminate the written word, and explores innovative ways to access information. At the same time, the day is a reminder of the importance of observing copyright laws that seek to promote creativity by assigning authors control of their work and ensure that they profit from their effort.

In celebrating this day, the library organised a reading session to create a platform for CUT students to share their reading experiences. The emphasis was on inviting participants to read out passages, quotations, paragraphs, etc. of words that had been instrumental in inspiring them in their lives. The event, held in the 24-hour study hall of the library, attracted a significant number of students and staff. The library management was particularly grateful to the Deputy Vice-Chancellor: Academic and Research, Professor HJ de Jager, for expressing a particular interest in, and support for, the event. Not only did he avail himself to officiate, but he also shared his inspirational passage. 47 students and staff members participated in the event.

• Yet another milestone was reached on 14 May 2013, when the library started operating the extended opening hours, following the recommendations of the Library and Information Services Working Group (LISWG) in the previous year. The recommendation was mooted earlier in 2012 by the Students' Representative of the LISWG. The library opening hours were increased by 6 hours per week. It was in the best interest of the library clients to extend opening hours in the evenings, and more particularly on Saturdays, to cater for library clients that were unable to access the library facilities during the day. To cushion the need for additional manpower to provide services late in the evenings, a number of students were recruited to provide assistance, as no additional library staff members were employed to affect this move.

- From 29 to 30 May 2013, the library organised a successful book exhibition at the Welkom campus. The essence of the book exhibition was to encourage academic staff members to select and recommend library materials for the library to purchase. Three book vendors were invited to the exhibition, and a total of 915 library materials were selected.
- An important landmark was reached when the library migrated to an updated version (2009) of the library system (Innopac) and a newly acquired server. The library system is used to manage acquisitions, cataloguing, serials, and circulations processes. Before the migration, the library operated on Innopac 2006, which had become dated. As a result, the library used to encounter numerous technical problems and found it increasingly difficult to conduct basic functions. The newer version was more versatile and had more functions than the 1996 version. In due course, the library would migrate to the latest version (Sierra), which would serve the library well into the future.
- On 2 and 3 September 2013, the library hosted another book exhibition at the Bloemfontein campus. Three book vendors were invited. To ensure that only relevant and appropriate books were selected, book vendors who were invited to exhibit were given strict guidelines on the subjects of books to bring. An examination of the materials brought confirmed that book vendors brought only study/research materials relevant to CUT programmes. Attendance could have been better, as only 31 academic staff members attended the event. Nevertheless, 2 894 titles worth R1 136 750.70 were selected for the different faculties.
- The CUT library was gradually embracing the development of an e-book collection. While hard copies of the library materials would still be maintained, a decision was made that it would be in the best interest of the institution if more resources were invested in electronic materials, including e-books. In September 2013, a trial of a select collection of databases from some e-book vendors was conducted among library clients to establish the usefulness and user-friendliness of their platforms to CUT clients. The response from library clients was promising, but not very encouraging. It was noted, for example, that for the SAGE Research Methods database, 48 sessions were logged and 150 searches made. This was not surprising, given that many of the library clients might not be familiar with the use of e-books. The library would have to devise more effective ways to sensitise and publicise the use and merits of these types of library resources.

- In the third quarter, following resignations, eight vacant posts were advertised in line with the approved library structure. Meanwhile, temporary and acting appointments were made to ensure continuity in the workflow. By the end of the fourth quarter, five positions were filled. It is hoped that all vacant positions would be filled in the course of the first quarter of 2014, and that the library would begin to operate with a full staff compliment.
- In keeping up with the library pledge to communicate library activities and developments and to
 engage the CUT community on issues of common interest, four issues of the library newsletter were
 published in 2013.

2.0 TRAINING PROGRAMMES

A number of training-related activities took place for staff and library clients.

2.1 Staff training, seminars and conferences attended

3.0 INFORMATION SERVICES

Throughout the year, the library provided information services to staff and students. Information services were offered in different formats. Assistance rendered ranged from providing basic skills in information searching (mostly for undergraduate students) to conducting in-depth and complex information searches on behalf of students and staff (mostly for postgraduate students and academics).

A new reporting format was adopted in 2013, following the approval of a new structure that introduced the concept of faculty librarianship. As a result, it was not feasible in a number of service areas, including training offered to students, to compare the statistics of 2012 and 2013. Comprehensive comparative statistics would only be presented in the reporting period for 2014.

From the table below it is clear that there was a steady increase in the number of postgraduate customised information services in 2013 in comparison to 2012. However, the number of quick-reference undergraduate queries dropped marginally.

3.3 Interlibrary loans

Interlibrary loan services are intended to supplement the library effort to meet the information needs of clients. This service is provided under an agreement between university libraries in South Africa to borrow materials that they do not have in their collections from each other. These services were only offered to postgraduate students and staff. Overall, there was a minimal drop in the number of interlibrary loan transactions in 2013 in relation to 2012. The pattern of request seemed to be consistent with the trends observed in the past years, where more requests were made by CUT for material from other libraries, while fewer requests for CUT materials were made by other institutions. A closer look at the data suggests that for every request made for CUT material (by other institutions), two were requested by CUT personnel. As such, CUT continued to be a net borrower of interlibrary materials.

4.0 ACQUISITIONS

Statistics of library acquisitions in recent years, including 2013, indicate that the library effort to increase the proportion of more up-to-date materials in the collection is paying dividends. Similarly, the change in favour of Science, Technology, Engineering and Mathematics (STEM), in line with CUT's mission, was embraced in the allocation of funding for library acquisitions.

For example, a total of 14 745 new library materials were added to the library in the period October 2011 to October 2013. Perhaps even more important was the growing representation of materials published in the last few years. As at the end of the year under review, 10% of the library collection at the Bloemfontein campus were published between 2010 and 2013. By contrast, only 2% of the library collection at the Welkom campus represented materials published in 2011. At the Kimberley branch library, the proportional increase of more recently published materials was even greater than that of the Bloemfontein campus library.

The growth in the STEM collection had been equally encouraging. For example, in 2011, the Bloemfontein campus library only had 170 books (2% of the library collection) representing study materials in the discipline of engineering and information technology. The following year (2012), this number increased to 437 (4% of the library collection). By the end of 2013, the collection substantially grew to 1 162 (11% of the library collection). It is hoped that this pattern would continue until a desirable proportion is achieved according to CUT's Academic Plan.

The tables below indicate the value of materials acquired in 2013 and 2012 respectively. Unfortunately, the over-expenditure on library materials that arose following acquisitions of library materials at the 2012 book exhibition accounts for the difference in the total value and the quantity of materials acquired.

5.0 CATALOGUING

Cataloguing functions involved a wide range of tasks besides cataloguing per se. As such, the reporting format was changed in 2013 to reflect the variety in tasks accomplished in the course of the year. However, the adoption of a new format meant that it would not be possible to make meaningful comparisons between the 2012 and 2013 data sets.

It should be mentioned that 81 periodical titles were sent for binding. It was planned that this activity would continue on an annual basis to provide easy access to old issues of printed journals, and also to ensure that related journal titles are not lost.

6.0 SYSTEMS

6.1 Databases

Subscription to databases is paramount in building the research capacity. Fortunately, the CUT LIS could maintain subscription to twenty databases; five individual e-journals and eight systems. Full-text databases included world-renowned information databases such as EbscoHost, ProQuest, ScienceDirect, the Web of Science and SA e-Publications. These have a high percentage coverage of peer-reviewed titles. Subscription to the five individual e-journals included access to paper copies of each title. The systems include the LIS integrated system software (Innopac); tools for the cataloguing department (e.g. SabiCat); and a referencing assistance tool (RefWorks). It is also significant to note that CUT researchers had access to open access titles.

6.3 LIS Electronic Resource Management System

The CUT LIS had the opportunity to implement and Electronic Resource Management System during 2013. This system does not only bring the CUT LIS on par with the rest of the more advanced library world, but is also necessary for a library and information service, as it promotes the LIS's e-resources to clients by enabling fluent and easy access to all subscribed e-content. The system also assists with the easy management of electronic resource licenses, and simplifies the process of solving subscription issues. In fact, it assists with all issues regarding electronic resources, including the harvesting of statistics.

During 2014, the LIS would install a new discovery tool (EBSCO's Discovery System) that would provide the CUT library community with a powerful discovery layer that would serve as a unified index of the library's entire resources with a single search experience.

These two products go hand-in-hand, and would enhance the entire information experience of the CUT library community.

7.0 CIRCULATION SERVICES

In the 2012 Annual Report, the library reported a steady increase in circulation statistics. We note that this trend has continued in 2013. The fact that this is happening simultaneously with the library collection expanding in more recently published material and also growing in its focus on STEM, is encouraging. Perhaps this is a sign that the library collection is maturing toward the tipping point. It would be interesting to observe what the 2014 circulation statistics would offer. With the library management's determination to continue its focus on increasing the proportion of more recently published materials and STEM, it is likely that the pattern of growth in circulation statistics would become the norm rather than the exception.

As is evident from the table below, 48 041 library materials went out on loan to library clients in 2013. In 2012, the number of library items that went out on loan was 42 443.
