## Fulbright Specialist Program

### *How to Apply for the Specialist Roster:*

Applications to the Fulbright Specialist Roster are accepted on a rolling basis and are evaluated by discipline peer review committees several times per year. They recommend qualified applications for final approval by the Presidentially-Appointed J. William Fulbright Foreign Scholarship Board. Approved candidates join the Roster for five years and are eligible to be selected for Fulbright Specialist projects.

Basic eligibility requirements include:

- U.S. citizenship at the time of application
- A Ph.D. or other terminal degree
- Substantial post-doctoral teaching and professional experience in the discipline

The Fulbright Specialist Program (FSP) promotes linkages between U.S. scholars and professionals and their counterparts at host institutions overseas. The focus of the FSP is educational capacity-building and the development of longer-term educational relationships. The program awards grants to qualified U.S. faculty and professionals, in select disciplines, to engage in short-term collaborative two- to six-week projects at eligible institutions worldwide.

### Fulbright Specialist Projects

Non-U.S. institutions interested in hosting a Fulbright Specialist from the Roster should contact their local Fulbright Commission or U.S. Embassy Public Affairs Section (if there is no Fulbright Commission) for instructions and guidelines.

Candidates on the Fulbright Specialist Roster may assist a prospective host institution in developing a project request, but they should not contact the Fulbright agency in that country directly.

Fulbright Specialist projects must address the needs of universities and education-focused institutions. Eligible activities include institutional or faculty development, lecturing, teacher-training, leading special conferences or workshops, and curriculum development. Projects are encouraged that contribute to the creation of new academic programs or fields of study at host country institutions of higher education; building of institutional relationships with U.S. academia; or strengthening of newly established or developing host country universities. Personal research and clinical medical research are not eligible.
